

PURPOSE

Our Pollution Policy focuses on reducing greenhouse gas emissions, primarily by switching to fossil-free fuels in our transport. Danske Fragtmænd A/S' lorries account for 94.2% of our total emissions, so in line with the Paris Agreement, we are therefore working hard to reduce our carbon emissions.

POLLUTION POLICY AND TARGETS

Danske Fragtmænd A/S wants to offer 100% emission-free transport by 2050, which means that we are working towards halving our transport emissions by 2030 and a further 20% by 2040 (all targets are in relation to the baseline year of 2020).

Employee and stakeholder engagement

We are committed to ongoing dialogue with our employees and stakeholders about our target of 100% emission-free transport solutions by 2050, which is why we conduct annual stakeholder surveys about our work to constantly ensure the right focus.

Innovation and technology

We need to offer our customers the best possible transport solutions. Therefore, we are continuously replacing our fleet with fossil-free vehicles. We also collaborate with relevant external parties, such as the Danish Technological Institute, to create technological solutions that can contribute to developing fossil-free transport and logistics solutions.
