PURPOSE

Danske Fragtmænd is dedicated to providing safe and reliable transport solutions that protect both our employees and other road users. Therefore, our Road Safety Policy aims to achieve a high standard of traffic behaviour and morality throughout the Group. We strive to:

- Create a good and safe traffic culture in the Group.
- Increase the safety of employees and drivers on the road.
- Minimise the number of injuries and accidents.
- Improve the working environment for drivers.
- Be known and respected internally and externally as a company that values road safety and continuously develops in this area.

WHO IS COVERED BY THE ROAD SAFETY POLICY?

The Road Safety Policy applies to all employees of the Danske Fragtmænd Group, including our carriers and regular subcontractors who drive commercially under the auspices of Danske Fragtmænd.

GOALS

Danske Fragtmænd will minimise the risk of traffic accidents and promote a safe traffic culture among our employees through continuous training and clear guidelines. We also want to contribute to society by increasing road safety among children and young people through education and campaigns.

INITIATIVES

Further training of drivers

We continuously invest in training our drivers to ensure they have the necessary skills and knowledge to drive safely in traffic.

Participation in road safety prevention among children and young people

We actively participate in preventing road accidents among children and young people by teaching school children about the dangers of right-turning lorries and participating in nationwide road safety campaigns. Our involvement in these activities aims to raise awareness of safe traffic behaviour from an early age.

Traffic rules of behaviour

We have set ten clear traffic rules of behaviour for all employees to follow to promote safety and responsibility in traffic.

1. You must always comply with applicable laws/traffic regulations. Remember the colour blue is an obligation - be a role model in traffic.
2. You must show consideration and drive responsibly in traffic. Give way to other road users and colleagues.
3. Do not read emails, text messages or PDAs while driving.
4. Minimise talking on mobile phones while driving and never use handheld mobile phones.
5. Never consume alcohol or other intoxicants in Danske Fragtmænd's vehicles or wearing Danske Fragtmænd's work clothes. Driving under the influence of these is not permitted under any circumstances.
6. Always keep your vehicle in order. Remember to adjust the mirrors and ensure the vehicle meets the legal requirements for brakes, lights, tyres, etc.
7. Avoid stress and fatigue by eating healthy and being well-rested.
8. Always wear a seat belt. Think about your family.
9. Pay special attention when turning right. Watch out for vulnerable road users.
10. Drive eco-friendly and economical. Avoid idling and take your foot off the accelerator.

RESPONSIBILITY FOR COMMUNICATION OF THE ROAD SAFETY POLICY

Danske Fragtmænd's management wants to ensure:

- The policy is continuously in focus in dialogue with and guidance of employees, subcontractors and others.
- Management actively contributes to ensuring the employee development and training (attitudinal and professional) necessary to fulfil Danske Fragtmænd's policy and goals.
- Procedures are in place to ensure corrective actions in case of systematic deviations with significant consequences.

AUDIT AND IMPROVEMENT

Danske Fragtmænd reviews the Road Safety Policy annually to check that it continues to reflect the company's goals and market conditions. We are committed to maintaining and improving our road safety management systems to meet the standards we have set.

APPROVAL

The Road Safety Policy has been approved by management and will come into effect from 1 July 2024. We encourage all employees to actively embrace the policy in their daily work to ensure and improve road safety.
